TD Investments

10k to be invested for the society, and 20k will be invested to go towards a bursary. Randal has recommended that the money be invested in a REIT (Real Estate Investment Trust), which he has also offered to monitor. The return on the investment may be upwards of and estimated 15%. The motion to invest in a REIT was put forth by Randal, seconded by Jo-Ann and approved by the Board.

Rental Policy

The 15% increase in the studio's rent will now be reflected in both rental policies effective October 1st, rather than September 1st, as per the minutes of the Board of Director's Meeting in June.
